As we discussed yesterday while visiting Brooks Park and the trails you were considering putting on the Board agenda restoring senior brunch money cut from the FY 2009 budget. The amount cut from the Senior's budget to reduce the number of brunches was \$7,500. By October 1, 2008 ¼ of the FY will have gone by leaving ¾ of the year to go. ¾ of \$7,500 is \$5,625. This would be the amount needed to restore lunches to a weekly event for the rest of FY 2009.

Since July 1 we have been holding a senior meals event two times per month. On the other Thursdays we have scheduled social activities.
