

BACKGROUND REPORT

Proposed Resolution R07-369

In accordance with the Stafford County Procurement Code and the Virginia Public Procurement Act, it is requested that the Stafford Fire and Rescue Department be allowed to purchase of medical supplies and equipment in an amount not to exceed \$130,000 from Boundtree Medical in Fiscal Year 2008. Stafford Fire and Rescue currently has a rider to the Fairfax County, Virginia contract for this vendor. This contract is used for the purchasing of medical supplies and equipment.

These supplies are used to restock fire and rescue apparatus countywide. This money is already in the Department's Fiscal Year 2008 budget.

Proposed Resolution R07-370

In accordance with the Stafford County Procurement Code and the Virginia Public Procurement Act, it is requested that the Stafford Fire and Rescue Department be allowed to purchase of personal protective equipment in an amount not to exceed \$200,000 from Maryland Fire Equipment for the Fiscal Year 2008. Stafford Fire and Rescue currently has a rider to the Montgomery County, Maryland contract for this vendor. This contract is used for the purchasing of personal protective equipment (PPE) for all fire and rescue personnel. The contract will also be used for the cleaning and repair of personal protective equipment.

This money is presently in the Fire and Rescue Department's Fiscal Year 2008 budget.
